

# AUTHOR GUIDELINES

#### **OPEN ACCESS FEE**

If the author requires his/her article will be published open access a fee of 50 € is required. The fee includes a complimentary online subscription.

#### PRINTED PUBLICATION

The journal is currently published online. Authors will receive a pdf of their published article.

# **GENERAL RULES**

Submissions are to be sent to editor@vejournal.org

**Please download the template** (https://www.vejournal.org/Template\_VEJ\_2025.docx) and use it to correctly conform your manuscript's format and structure.

Manuscripts should follow the guidelines and be intelligible to as wide an audience as possible. Authors are requested to check their manuscripts very carefully for syntax, spelling, grammar, and punctuation errors before submission.

Non-compliance to any of the above points may result in rejection of the manuscript.

The Editorial Board will decide to either reject the manuscript or send it out for double blind review. The initial screening result will be sent to the corresponding author(s) via email within a month.

Each manuscript passing initial screening will be subjected to rigorous and anonymous peer-review by two peer-reviewers.

The Editorial Board will make every effort to ensure timely reviews and communicate an editorial decision in about 4 months after the receipt of the manuscript.

After the revision process, qualified manuscripts will be accepted for publication.

The Editorial Board will advise the author(s) if any verification of the language by a native speaker is required prior to publication.

Please, don't submit your proposal in August.

# 1) ARTICLES

4.500-9.000 words in .doc format, excluding footnotes, references, and captions.

Times New Roman font in size 12, footnotes in size 9, single line spacing. Title in lower case in size 14, bold, centered.

Images must be placed in the body of the text. Each image receives a number (Fig. 1, Fig. 2, etc.). Legends and credits or sources must be placed under images. The text must explicitly refer to images.

Images must be sent separately (300 DPI resolution).

#### 2) REPORTS

4.000-5.000 words in .doc format.

Times New Roman font in size 12, footnotes in size 9, single line spacing. Title in lower case in size 14, bold, centered.

Images must be placed in the body of the text. Each image receives a number (Fig. 1, Fig. 2, etc.). Legends and credits or sources must be placed under images. The text must explicitly refer to images.

Images must be sent separately (300 DPI resolution).

#### 3) FIELDWORKS

4.500-9.000 words in .doc format, excluding footnotes, references, and captions.

Times New Roman font in size 12, footnotes in size 9, single line spacing. Title in lower case in size 14, bold, centered.

Images must be placed in the body of the text. Each image receives a number (Fig. 1, Fig. 2, etc.). Legends and credits or sources must be placed under images. The text must explicitly refer to images.

Images must be sent separately (300 DPI resolution).

#### 2) BOOK REVIEWS

800-8.000 words in .doc format.

Times New Roman font in size 12, footnotes in size 9, single line spacing. Title in lower case in size 14, bold, centered.

#### EACH SUBMISSION should be accompanied by:

- 1) name(s) of author(s) followed by affiliation(s) and email address;
- 3) biographical note of author(s) (maximum 8 lines);
- 2) English abstract (maximum 12 lines);
- 4) a list of English keywords (5-10);
- 5) images at 300 DPI (send them via Wetransfer to editor@vejournal.org)

#### COPYRIGHT PERMISSIONS AND CONSENT FROM IMAGE SUBJECTS

Authors should be aware of any cultural sensitivities or restrictions associated with any images included in their manuscripts. Appropriate ethical guidelines should be adhered to by considering the views and approval processes of the affected subjects and communities.

If any image has been obtained from communities where additional permissions are required, or from a protected source (e.g. museum collections), then authors must obtain the required permissions for use prior to submission of the manuscript.

Content (e.g. photographs, video or audio recordings, illustrations, etc.) which can reveal the identity of study participants or study subjects can only be included if they (or parents/guardians if they are underage or considered unable to provide informed consent, or their next of kin if participants are deceased) have provided consent to publish.

Any images or figures which have been obtained from another published source, can only be reused if authors have obtained the appropriate permissions for re-use from the copyright owner.

The original source of the image must be cited, even in cases where the image is not under copyright, or if re-use is allowed under a license which permits unrestricted re-use.

Authors should include a statement to confirm that all necessary permissions have been obtained.

## **QUOTATION NORMS**

For **short quotations**: quotation between double inverted commas ("...") in the body of the text, followed by the author's name, year of publication, page number, between brackets. Please use "...". Don't use «...».

For a quotation within a quotation, use single inverted commas ('...').

For **long quotations** (more than three lines of text): enter the quotation as a separate paragraph, size 11, indent the paragraph (0.8 cm indentation, left and right), do not use quotation marks, leave a blank line above, and below the quotation.

## Examples

(Barbash 2001: 380) (Mignolo and Escobar 2010: 64) (MacDougall 1998: 15-17)

Ellipses are signaled with square brackets ([...]).

For single terms use '...'. Examples: 'Semitic peoples' or 'planned integration'.

In a note, when the reference is identical to the preceding note's: *Ibid*. When the reference is the same, but the page changes: (ivi, p.). Example: (ivi: 99). In other cases, repeat: Last name (date: p.). Example: Goodman (1968: 99).

#### REFERENCES

Bibliographic references should be placed at the end of the article, in alphabetical order. Only works mentioned in the text are to be placed in the Bibliography. Please, pay attention that author's first name should be complete, not dotted.
